A grade is to be calculated by exam board based on previous data.

Unit 3 which was meant to be sat by students this summer was cancelled. SEL has regularly assessed students. Data has been used by SEL to indicate performance for this unit.

All other portfolio units have been completed and submitted in the same format. Assessment has been done following the simple P/M/D grading system. Work has been moderated against exemplar material issued by our centre moderator. Individual teachers are responsible for their own unit of work.

Students have completed a substantial amount of portfolio work which has given us a clear indication on students performance.
